This occasion presents a perfect opportunity to examine the evolution of the Convention and its impact, both in specific member states and generally in Europe. In this conference – in addition to the general history of the Convention – we aim to assess the impact of the Convention on the freedom of religion or belief. ORFECT (Observatory on Religious Freedom in the jurisprudence of the European Court of Human Rights) and ICLARS (International Consortium for Law and Religion Studies) will also be present at the conference as a collaborating partner.
