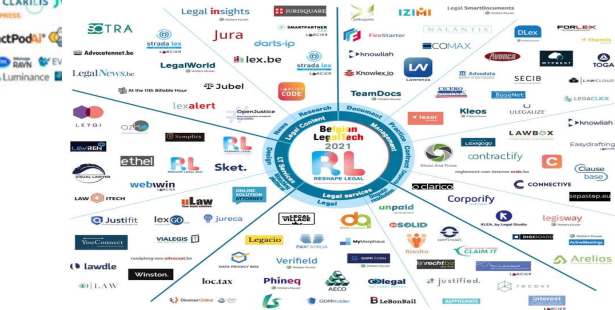
Legaltech, also known as lawtech, is the use of technology to provide legal products and services.

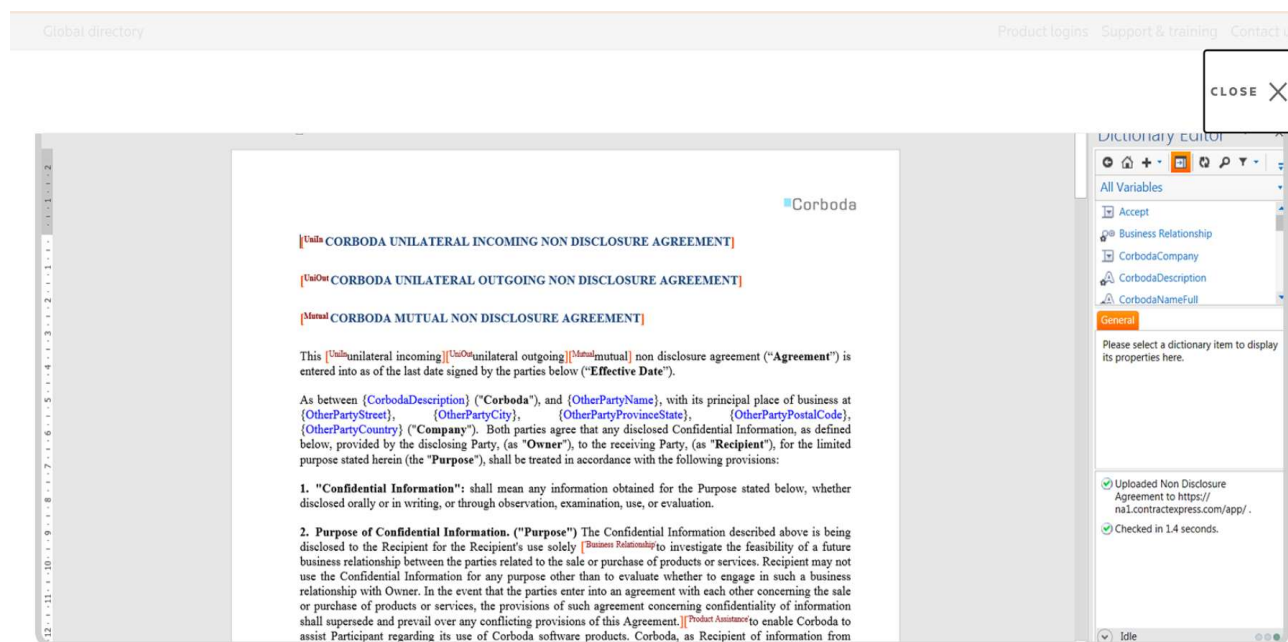

2 COSTS AND OUTGOINGS

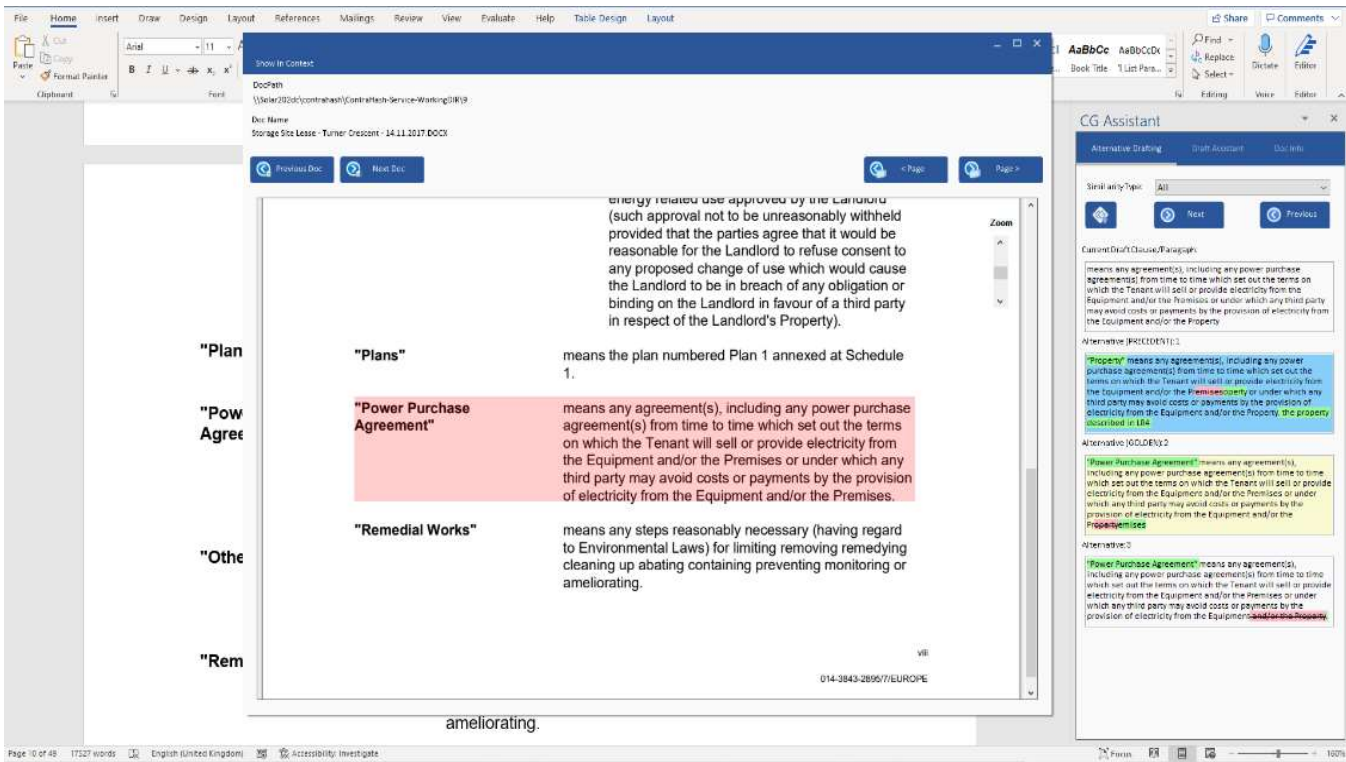
